1.0 INTRODUCTION

Article 241.1 of the Education Act allows school boards to grant a derogation, to the age of admission to preschool and primary education," for humanitarian reasons or to avoid causing a serious prejudice to a child."

It is, therefore, on the basis of a convincing presentation of the existence of a **real and serious prejudice or for humanitarian reasons** that could affect a child, that requests for derogations, generally addressed to the school by the parents or guardians, are processed.

The school is the first level of treatment of derogation requests. It has the duty to inform applicants on how to prepare a file. It must ascertain that supporting documents are attached to the file according to the nature of the request; baptismal certificate or birth certificate, proof of out-of-Quebec schooling, proof of temporary stay, case study report or, if need be, a psychological evaluation. This should be drawn up by a competent professional who, preferably, is not in the employ of the Central Québec School Board. All costs are to be assumed by the parents.

Furthermore, the school must ensure that, for all requests other than those concerning a temporary stay (#3.2.4 p. 6), the continuation of schooling already begun (#3.2.5 p. 6), or a sibling born within the year (#3.2.7 p. 7), the file shows real or anticipated prejudice.

The psychological evaluation and the case study report must be sufficiently explicit to permit an enlightened decision. For requests of early entry into first grade, an evaluation of the child's acquired skills and a demonstration of the pertinence of the derogation are also necessary.

2.0 IDENTIFICATION OF THE ARTICLE OF THE EDUCATION ACT REFERRED TO IN THE REQUEST

- **Art. 241.1:** For humanitarian reasons or to avoid causing a **serious prejudice** to a child who has not attained the age of admission, the school board may, following a request giving reasons therefore made by the parents, in cases determined by regulation of the Minister.
- 1) admit the child to preschool education for the school year in which he attains 5 years of age, or admit him to elementary school education for the school year in which he attains 6 years of age;
- 2) admit to elementary school education a child admitted to preschool education who has attained 5 years of age.

In the event of refusal by the school board, the Minister may, at the request of the parents and, if he considers it expedient on the grounds mentioned in the first paragraph, order the school board to admit the child, in the cases and subject to the conditions prescribed in the first paragraph.

3.0 EXPLANATORY NOTES FOR SCHOOL ADMINISTRATION

The following section is made up of information on each criterion to justify a derogation request. You are asked to look over these instructions and requirements carefully.

3.1 CHILD IDENTIFICATION

It is important to check surnames, names and birth dates as they appear on the birth certificate or baptismal certificate.

3.2. JUSTIFICATION OF THE REQUEST (Criteria)

A school board may, in accordance with paragraph 1 of section 241.1 of the Education Act (R.S.Q., c. I-13.3), admit a child to school who has not attained the age of admission in the case of:

3.2.1 A precocious child ready to start preschool or primary education

A child who is ready to begin preschool or elementary school owing to his advanced intellectual, social, emotional and psychomotor skills. **The** assessment must indicate clearly the nature of the foreseen prejudice.

Required Documentation - a), b), d), k) and, as required, j) [see p. 13]

The following steps must be followed:

- Step 1: Give the parent a copy of the Request for Derogation Form;
- Step 2: Interview with the parents and child for a 1st evaluation by the Principal;
- Step 3: If possible, the School Derogation Committee should place the child in a classroom setting for observation; (this committee could be composed of: e.g. K or primary teacher, a professional if available and the school principal)
- Step 4: Psychological evaluation by a psychologist or psycho-educator (not in the employ of the school board). The parents will assume the cost for this evaluation.

This assessment may be done in the child's mother tongue and must include pertinent data and observations, particularly with respect to the child's intellectual capacity, social and emotional maturity and psychomotor development.

3.2.2 Admission to primary education of a 5-year old preschool student

This promotion from preschool to first grade, in the beginning of the school year, is reserved to children for whom there has been no other derogation granted (criteria #1).

The parties concerned (parents, principal, preschool & primary school teachers and competent professional from the school) must show that it would be detrimental for the child to remain in preschool because of his acquired skills and exceptional development.

• Required Documentation – a), b), d), k) [see p. 13]

The following steps must be followed:

- Step 1: Give the parent a copy of the Request for Derogation Form;
- Step 2: Interview with the parents and child for a 1st evaluation by the Principal;
- Step 3: The preschool teacher must show that the child has already attained the level of development generally reached at the end of the school year. The first grade teacher must evaluate this development as well as the child's social ability to integrate into the first grade as well as the child's social ability to integrate into the first grade as well as expectations of his/her success. The principal should collaborate in this process. Finally, the file should be completed with an opinion from the school professional.

3.2.3 Early admission due to projected low enrolment the following year

A child whose early admission is required to ensure that he will be with a group of students in the school in which he is to be enrolled for elementary school education. This is only in cases where the school board does not expect to be able to form a preschool class the following year.

It must be very clear that, the following year, there will not be a sufficient number of students to have a preschool in this elementary school. Distance nor the absence of other children in the immediate neighbourhood are not reasons to be used.

The file must clearly show this situation.

• Required Documentation - a), b) g) & k) [see p. 13]

3.2.4 A student who is residing temporarily in Québec

A child whose domicile is outside Quebec but temporarily resides in Quebec because his parents have been assigned thereto for a maximum period of 3 years and whose early admission would enable him to attain an equivalent level in the official education system outside Quebec.

Required Documentation - a), b) f) & k) [see p. 13]

3.2.5 A student who has already started school outside Québec

A child who, while domiciled outside Quebec, began or completed his preschool or elementary school education in an official education system outside Québec.

• Required Documentation - a), b), c) &/or d) & k) [see p. 13]

3.2.6 A student experiencing a particular family situation

A child who is experiencing a family or social situation which, owing to special circumstance or events, justifies his early admission to school.

These applications must be supported by the opinions of specialists in the field of Health and Social Services or Youth Protection Services.

Required Documentation - a), b), h) & i) & k) [see p. 13]

3.2.7 A sibling born within a 12-month period

A child who has a brother or a sister born within 12 months following his birth and is eligible to begin school the same year.

• Required Documentation - a), b) &k) [see p. 13]

3.2.8 A child with serious mental or physical handicaps

A 4-year-old child with a serious mental or physical handicap or with marked social or emotional disturbances whose school board is not included on the list of school boards established under section 33 of the Basic School Regulations for Preschool and Elementary School Education.

• Required Documentation - a), b), e) j) & k) [see p. 13]

Note: Preschool and elementary instruction

In accordance with Article 96.17 and 96.18 of the Education Act, the following is the **responsibility of the School Principal:**

Following a request, with reasons, from the parents of a child who has not achieved the objectives of preschool education, the principal may admit the child, as prescribed by regulation of the Minister, to preschool education for the school year in which he would be eligible for admission to elementary school education if there are reasonable grounds to believe that such measure will enable the child to achieve those objectives.

Following a request, with reasons, from the parents of a student who has not achieved the objectives or mastered the compulsory notional contents of elementary school education at the end of the period fixed by the basic school regulation for mandatory promotion to secondary school, the principal may admit the student, as prescribed by regulation of the Minister, to elementary school education for an additional school year, if there are reasonable grounds to believe that such measure will enable the student to achieve those objectives or master those notional contents.

Each year, the principal shall submit a report to the school board on the number of students admitted in these categories.

For criteria 1 - 3 - 6 - 7 - 8

5.0 INFORMATION DOCUMENT FOR PARENTS

REQUESTS FOR A DEROGATION TO THE AGE OF ADMISSION TO PRESCHOOL AND PRIMARY EDUCATION

This note is addressed to parents (or guardian) whose children are born a few days or months after the deadline date, that is September 30th. This is to help you decide whether your child would benefit from a derogation and the procedure to follow in making such a request if your child falls into the following criteria:

a child who is particularly capable to begin preschool or the first grade and, therefore, his/her. development is such that it would be a grave prejudice if he/she were not allowed to be enrolled.

It must be clear that, in order to be eligible for a derogation, it must be shown that the child's development level is superior to the average for children of the same age (the intellectual level, maturity, autonomy, etc.). More than that, the development of the child must be such that, if admission was refused, it would be detrimental to his/her development. It is important to underline that a derogation to the age of admission is an exceptional measure.

The conditions may seem excessive, but they are necessary for the educational success of the child. It should be noted that children admitted by derogation are not just born 10 or 20 days after the deadline (30 September), but have a difference in age of around 7 months with their peers. There is a significant difference at this age with regard to the psychological and physical maturity of the child.

As a result of surveys done by different school boards, the biggest difference between derogated students and their peers is in regard to behaviour in the classroom (e.g. less interest, not as independent, an inferior ability to concentrate as well as a shorter attention span). The results of this survey confirmed the impact of a difference in age on the behaviour of a class and the importance of a strict process in the admission to children before they attain the required age.

Before you decide to request a derogation, we would ask you to think about and ask yourself certain questions: "Does your child show a strong desire to attend school or is this your wish? Does you child possess the required aptitudes necessary to receive a derogation?"

Your child should have the ability to succeed and should not be placed in a situation where he/she could fail or always fall only in the average of their group throughout their primary education because of the fact that all the other children have the advantage of age

If, after consideration, you judge that your child's development is such that he/she should have a derogation to the age of admission, we invite you to fill out the required forms and supply the school with an evaluation by a psychologist, who is a member of the "Ordre des psychologues de Québec".

We hope that this helps to clarify the derogation procedures and thank you for your cooperation.

6.0 INFORMATION DOCUMENT TO ACCOMPANY APPLICATION FORM

REQUESTS FOR A DEROGATION TO THE AGE OF ADMISSION TO PRESCHOOL AND PRIMARY EDUCATION

- 6.1 Parents of children who have not attained the age of five (5) before October 1 may apply for a derogation, which permits early access to kindergarten.
- 6.2 Parents of children who have not attained the age of six (6) before October 1 may apply for a derogation, which permits early access to elementary school (grade 1).
- 6.3 Requests should be made directly to the school. School authorities will offer assistance in completing the necessary forms.
- 6.4 Applicants will be required to submit:
 - 6.4.1 A written request for a derogation outlining the reasons deemed important for the child to receive early admission;
 - 6.4.2. The child's birth certificate.
- 6.5. For purposes of assessment, all children, who have had a request submitted in their name, will meet with a committee composed of the school authority, the teacher concerned and, in some cases, a psychologist and/or guidance counsellor.
- 6.6 Following this, the parent may be required to supply a psychological assessment, obtained from a practising member of a recognised Corporation of Psychologists or Guidance Counsellors.
- 6.7 If the child is under the protection of a social agency, a recommendation from the respective competent authorities might also be requested.
- 6.8 The dossier must be completed and returned to the school before March 25 to be given consideration for the following school year. The school will then forward the dossier to the School Board.
- 6.9 The Director of Educational Services will study the dossier and make a decision.
- 6.10 The school authority will contact the parent immediately after receiving the Director's decision.
