Biographical Notes and Administrative History:

The School Municipality of Chicoutimi does not have any schools under its control. Students from its territory attend the following schools:

- Kenogami Protestant High School, in Kénogami;
- Arvida High School, in Arvida; or
- Corbett Memorial School (R.C.A.F.), in Bagotville.

The minutes report several situations of school transport management related to these schools. There is no mention of any teachers since the school municipality has no school. In March 1960, the Quebec Department of Education approved, for academic purposes, the merger of the dissentient school municipalities of Chicoutimi and of the Town of Chicoutimi Nord.

In 1962, the merger of school trustees in the Saguenay region, namely Arvida, Chicoutimi (including Chicoutimi Nord) and Kénogami (including Jonquière), led to the creation of the Protestant School Municipality of Saguenay Valley. Subsequently, several mergers followed at different times: Saguenay "P" School Board, Eastern Québec Regional School Board (EQRSB) and Central Québec School Board (CQSB).

Price Brothers Company and the Chicoutimi school trustees seem to be very close; in addition to offering its premises for meetings, the company's letterhead is sometimes used for administrative purposes.

The *Commission scolaire de la Cité de Chicoutimi* (French) maintained school relations with school trustees in 1952, particularly with respect to the payment of Protestant property taxes.

Localisation:

The only known address is as follows:

• Postal code 68, Chicoutimi.

According to the minutes, the school trustees' meetings were held at Price Brothers' offices in Chicoutimi. Some correspondence from school trustees was occasionally addressed to the care of the Price Brothers company.

Conservation History:

The documents, originating from the Saguenay region, are stored in a vault under controlled environmental conditions at the Central Québec School Board's Document Management Centre located at the Eastern Québec Learning Centre in Québec City.

Scope and Content:

The documents testify to the documentary management of the school municipality of Chicoutimi and summarily of the school municipality of Chicoutimi Nord. The evolution of teaching activities, the reflection of the linguistic and cultural situation as well as administrative activities are represented by the archival group.

Support:

All documents in the series are in paper form. No objects (trophies, flags, etc.), graduation albums or student photos can be found.

Preservation State:

The documents are in good condition for consultation and digitization, if necessary. Pins, paper clips and nails were removed to limit rust damage.

Language of the Documents:

Most of the documents are in English; some documents are bilingual, English and French. Some documents have been translated into French.
