

COVID-19 GUIDELINES FOR CANDIDATES

According to the guidelines issued by the Minister of Education and the Director General of Elections, the following guidelines must be respected by candidates who are depositing their nomination papers with the Returning Officer or with the Person Designated to receive nomination papers.

Call for an appointment before coming to deposit your nomination papers.

→ For all candidates from the Greater Québec City – Lévis region, contact the Returning Officer at (418) 688-8730, ext. 3210.

At this appointment, the following guidelines must be respected:

- You must wear a mask;
- You must disinfect your hands;
- Bring your own pen or pencil;
- Disinfect your hands before leaving;
- Respect a 2-meter distance between the candidate and the person designated;
- Register upon arriving in case we need to conduct COVID-19 contact tracing.

A person candidate or his mandatary should be aware when collecting signatures of the heightened risk to persons over 70 years of age, persons having chronic illness or having a diminished immune system.

The person under quarantine or under isolation measures should avoid soliciting signatures when:

- He has just returned from a trip abroad;
- He has received a diagnosis of COVID 19 and is still considered to be contagious;
- He presents symptoms of the disease ([COVID-19 Symptom Self-Assessment Tool](#)) ;
- He has been in contact with a person with a suspected, probable or confirmed case of COVID 19 within the last 14 days;
- He is awaiting the result of a COVID 19 test.
