POLICY ON REMUNERATION AND CONSTITUENCY EXPENSES OF THE COUNCIL OF COMMISSIONERS

(Adopted September 15, 2017)

POLICY

Note: The masculine gender is used throughout this document for the sake of conciseness and is meant to be inclusive of both genders.

LEARNING FOR ALL

1.0 POLICY INTRODUCTION

As elected officials representing their community, School Commissioners must familiarize themselves with the issues that concern them and inform their parents, electors, governing boards and their respective communities as to decisions taken by the members of the Council of Commissioners on their behalf.

Time Commitment from each elected official to attend meetings of the Council of Commissioners, as well as other Standing or Ad Hoc Committees, is paramount to ensure that the best decisions are taken for the organization in order to achieve our common goal - student success.

The Central Québec School Board is committed to determine remuneration at reasonable levels commensurate with the duties and responsibilities of each elected official, and mindful of the overall needs of the community, etc.

Commissioners will be reimbursed for expenses incurred whilst fulfilling their various obligations and duties.

2.0 PURPOSE

This policy is intended to establish the remuneration available to members of the Council of Commissioners as well as to determine an amount for expenses incurred when carrying out official duties.

3.0 SCOPE

This policy applies to all members of the Council of Commissioners.

4.0 GENERAL GUIDELINES

- a) Parameters set forth in the yearly decree by the Government of Québec regarding the remuneration of School Commissioners will be used to determine overall funds required to disburse stipends for elected officials as well as budgetary amounts set aside to cover related expenses.
- b) Effective July 1 of each school year, the School Board may decide to adjust the base remuneration of Commissioners.
- c) Base remuneration is an all-inclusive amount provided to members of the Council of Commissioners for their time and service with respect to attending School Board matters, including meetings of the Council of Commissioners, Standing Committees, etc. It includes preparation time (review of materials, data, meetings with various stakeholders as required, etc.).
- d) In accordance with the decree, one-third of the annual remuneration paid to a Commissioner will be paid as an allowance for expenses related to their duties and will not be counted as a taxable income.



- e) Base remuneration will be paid bi-weekly, via direct deposit, as per the School Board's Pay Calendar.
- f) Stipends for members of the Council of Commissioners, Chairman and Vice-chairman are listed in Appendix A.
- g) A per diem amount, except for the Chairman and Vice-chairman, may be reserved in the budget to recognize attendance at the following Standing Committees (Executive Committee, Audit Committee, Human Resources Committee, Ethics and Governance Committee).
- h) Other amounts to cover constituency expenses that may be incurred by Commissioners, such as travel expenses, professional development activities, cellular phones, meetings for constituency purposes, public relations activities, etc. will be reviewed and budgeted on a yearly basis.
- i) Reimbursement of expenses will be processed according to the School Board Travel and Living Expenses Reimbursement Policy.

5.0 ABSENCES (except for illness - Commissioner or Immediate Family Members)

Attendance at Board meetings is most important to ensure that meetings are productive and that valuable discussions take place to ensure that the best decisions are taken in the interest of the organization, our students and our constituents.

Failure to regularly attend meetings of the Council of Commissioners and Standing Committees will be addressed on an individual basis by the Chairman.

The Board reserves the right to ask Commissioners to step down from their position when their level of absenteeism is deemed to be high and, as a result, jeopardizes the Board's ability to take important decisions in a timely manner.

For the management of Commissioners' absences, the Board reserves the right to retain an amount from the yearly stipend. If no absences occur, this amount would be paid back to the Commissioners in June of each school year. If absences occurred, deductions of \$100.00 per absence, up to a maximum of \$400.00 per school year, would be applied. This adjustment would be carried out in June of each school year.

6.0 EXCEPTIONS

Exceptions to this policy may be made by a majority vote of the Council of Commissioners.
