WHEREAS Jimmy Sandy Memorial School organised the 2015 Central Québec School Board (CQSB) Basketball Tournament with the CQSB Department of Complementary Educational Services;

WHEREAS the event included not only the annual CQSB Basketball Tournament but also an important cultural exchange between the Naskapi nation and students from eight CQSB secondary schools in the southern part of the province;

WHEREAS the distance of the event to the other schools of the Central Québec School Board entailed a significant effort regarding the logistics of travel to and from the event, the meals, the lodging the tournament and a number of First Nations cultural activities;

WHEREAS the quality of the welcome within the school as well as within the community was exceptional on every level;

#### c) Consortium of School Boards: Liability Insurance Portfolio

WHEREAS the liability insurance portfolio obtained through the consortium of school boards located in administrative regions 01, 02, 03, 04, 09, 11 and 12 has proven to be financially advantageous;

WHEREAS it would be beneficial to maintain this consortium for the year 2015-2016, according to the advice received;

WHEREAS the *Commission scolaire des Appalaches* has agreed to represent the consortium of school boards in its dealings with Guy Turcot of GT&A *gestion de risque inc*;

WHEREAS it is in the interest of the Central Québec School Board to maintain membership in the consortium;

It was MOVED by A. Visser, SECONDED by K. Jack and UNANIMOUSLY RESOLVED; THAT the Central Québec School Board renew its membership in the consortium of school boards in administrative regions 01, 02, 03, 04, 09, 11 and 12 for the renewal of its liability insurance for the 2015-2016 school year; and

THAT the firm of *GT&A* gestion de risque inc. be mandated to negotiate de gré à gré (mutual agreement) with AON, insurance brokers, under the renewal option clause, or to prepare a public call for tenders for the renewal of liability insurance for all the school boards that are part of the consortium; and

## c) Consortium of School Boards: Liability Insurance Portfolio (continued)

THAT the School Board mandate, if applicable, the *Commission scolaire des Appalaches* to carry out the public call for tenders according to that school board's current policies and procedures and to accept joint responsibility in this regard; and

TO commit to accept after presentation of the firm analysis report *GT&A* gestion de risque inc., the result of these negotiations or the tender for all school boards that participated in the consortium and;

THAT the Secretary General be authorized to sign all documents pertaining to the insurance policy.

#### d) 2015-2016 School Calendar (Adult and Vocational Sector) (adoption)

WHEREAS section 238 of the Education Act stipulates that every school board shall establish the school calendar of its schools, taking into account the provisions of the basic school regulation;

WHEREAS the teachers' collective agreement provides for a committee that is consulted on the school calendar;

WHEREAS the calendar was officially adopted on February 9, 2015 by the EQLC General Assembly;

WHEREAS the calendar was passed through school council at the meeting held on January 27, 2015;

WHEREAS both committees recommend the adoption of the proposed calendar for the 2015-2016 school year;

It was MOVED by H. Clibbon, SECONDED by C. Guay and UNANIMOUSLY RESOLVED; THAT the Central Québec School Board accept the school calendar (Adult and Vocational Sector) for the 2015-2016 school year as in **Appendix 1** to the minutes.

e) Derogation to the 2014-2015 School Calendar (Québec City)

WHEREAS, the 2014-2015 School Calendar for the Youth Sector was unanimously adopted by the Central Québec School Board Council of Commissioners on January 17, 2014;

WHEREAS the Central Québec School Board Early-Childhood Learning Committee has organised its Early Childhood Symposium for March 26th and 27th, 2015;

WHEREAS March 27, 2015 was officially designated, in the 2014-2015 School calendar as a snow day;

WHEREAS the Central Québec School Board does not have the budget to hold the symposium over 2 days if the pedagogical day gets cancelled;

WHEREAS derogation is required in order to ensure that March 27, 2015 be designated a pedagogical day and not a snow day;

WHEREAS the Central Québec School Board Administrative Council was consulted regarding this change;

WHEREAS the Teachers' Union President has been consulted and recommends the acceptance of the proposed derogation;

It was MOVED by A. Visser, SECONDED by D. Ford-Caron and UNANIMOUSLY RESOLVED; THAT the Central Québec School Board accept the derogation to the school calendar (Youth sector) for the 2014-2015 school year in the Québec region; and

THAT March 27, 2015 be the official pedagogical day and April 24, 2015 be a snow day.

# 15-02.18 Request for the Revision of a Recommendation made by the Student Ombudsman (in-camera)

WHEREAS the incident in question is considered as gross misbehaviour, as defined in the Central Québec School Board Transportation Policy;

WHEREAS gross misbehaviour is punishable by immediate, indefinite suspension;

WHEREAS according to the By-Law Respecting the Complaint Examination Procedure Established by the Central Québec School Board, the Council of Commissioners has the right to retain or not retain a recommendation of the Student Ombudsman;

WHEREAS the incident in question has caused significant and ongoing repercussions for child (B) and for the child's family members;

WHEREAS this was not an isolated incident;

WHEREAS child (A) is being provided with exceptional, personalized, full-time services and ample socialization opportunities within the school day;

WHEREAS the Central Québec School Board will be ensuring continued follow-up procedures to assist both child (A), child (B), and the family members of both children;

WHEREAS the Central Québec School Board will be reviewing its protocol regarding the handling of similar future incidents;

WHEREAS the Council of Commissioners feels it is in the best interest of both students to avoid being in contact with each other during transportation;

It was MOVED by K. Jack, SECONDED by C. Guay and UNANIMOUSLY RESOLVED; THAT child (B) be reinstated onto the bus on a full-time basis; and
