16-03.10 New Business

a) 2016-2017 School Calendar (Adult and Vocational Sector) (adoption)

WHEREAS section 238 of the Education Act stipulates that every school board shall establish the school calendar of its schools, taking into account the provisions of the basic school regulation;

WHEREAS the teachers' collective agreement provides for a committee that is consulted on the school calendar;

WHEREAS the calendar was officially adopted on March 4th, 2016 by the EQLC General Assembly;

WHEREAS the calendar was passed through school council at the meeting held on December 1st, 2015;

WHEREAS both committees recommend the adoption of the proposed calendar for the 2016-2017 school year;

It was MOVED by H. Clibbon, SECONDED by K. Jack and UNANIMOUSLY RESOLVED; THAT the Central Québec School Board accept the school calendar (Adult and Vocational Sector) for the 2016-2017 school year as in **Appendix 1** to the minutes.

b) Renewal of a Contract: Student Ombudsman

WHEREAS the Education Act requires school boards to designate a person to act as Student Ombudsman;

WHEREAS the Regulation respecting the Complaint Examination Procedure established by a school board stipulates that the term of office for the Student Ombudsman may not be less than three years;

WHEREAS at a Regular Meeting of the Council of Commissioners held on February 8, 2013 Ms. Anne Letellier de St-Just's contract was renewed as Student Ombudsman for the Central Québec School Board for the period of July 1, 2013 to June 30, 2016;

WHEREAS the Central Québec School Board entered into a contract with Ms. Letellier de St-Just and the contract specified the remuneration and expenditures to be paid to her;

WHEREAS the Central Québec School Board is very satisfied with the services rendered by Ms. Letellier de St-Just;

It was MOVED by A. Visser, SECONDED by D. Ford-Caron and UNANIMOUSLY RESOLVED; THAT the Central Québec School Board designate Ms. Anne Letellier de St-Just to be the Student Ombudsman for the period of July 1, 2016 to June 30, 2019, with an increase in the retainer fee from \$2,000 to \$3,000 and under the same terms and conditions as the current contract.

c) <u>Hiring of a General Contractor: Riverside Regional Renovation Project</u>

WHEREAS the Central Québec School Board had reserved part of the *Maintien des bâtiments* budget to carry out the Riverside Regional Renovation Project;

WHEREAS plans and specifications were prepared and a public call for tenders for general contractors was published on SEAO (*Système électronique des appels d'offres du gouvernement du Québec*) on February 4th, 2016 and tenders were opened on March 3rd, 2016;

WHEREAS the lowest tender meets the requirements and specifications of the project;

It was MOVED by D. Ford-Caron, SECONDED by W. Marois and UNANIMOUSLY RESOLVED; THAT the Central Québec School Board's Council of Commissioners accept the lowest tender that met the specifications for the Riverside Regional Renovation Project (1750, rue Joule, Jonquière, QC G7S 3B1) as submitted by *Les Constructions Technipro Inc.*, (3447, rue du Transport, Jonquière, QC G7X 0B6) in the amount of \$2,770,000.00 (taxes not included); and

THAT the Director General be authorized to sign the contract on behalf of the School Board.
