The Assistant Director General, Nancy L'Heureux, reported on the progress of the action plans for the month of December.

#### 23-12.13 New Business

### a) Criteria for the Admission and Enrolment of Students 2024–2025 (adoption)

WHEREAS appropriate consultation on the draft Criteria for the Admission and Enrolment of students for the 2024–2025 school year has taken place,

WHEREAS Section 239 of the Education Act stipulates that the criteria must be adopted, put into force, and sent to each governing board at least 15 days before the beginning of the student enrolment period;

WHEREAS the enrolment period for the 2024–2025 school year will be from February 5, 2024, to February 16, 2024;

It was MOVED by I. O'Gallagher, SECONDED by F. Pedneault, and unanimously RESOLVED; THAT pursuant to Sections 4, 213, and 239 of the Education Act, the Central Québec School Board adopt the Criteria for the admission and enrolment of students for the 2024–2025 school year as presented.

## b) Choice of Date of Annual Public Meeting to Present the Annual Report (adoption)

WHEREAS as per Section 220 of the Education Act, every school board must invite the public to an information meeting at least once a year;

WHEREAS public notice specifying the date, time and place of the meeting must be given not less than 15 days before it is held;

WHEREAS during the meeting, the commissioners must present the content of the annual report and answer any questions concerning the report;

It was MOVED by H. Clibbon, SECONDED by J.-A. Toulouse, and unanimously RESOLVED; THAT the Council of Commissioners sets the date of Annual Public Meeting to present the annual report to February 21, 2024.

### c) Division of the Territories of the School Board for the Electoral Map (adoption)

WHEREAS the Act Respecting School Elections requires that the territory of school boards be divided into electoral divisions according to the number of electors;

WHEREAS at the November 15, 2023, meeting of the Council of Commissioners a resolution was adopted accepting the proposal for the division of the territory of the school board into eleven electoral divisions:

WHEREAS a public notice was published giving electors 15 days to signify their disagreement with the proposal and no notices were received during the period;

WHEREAS the Act Respecting School Elections requires school boards to adopt the final electoral divisions no later than December 31 of the year preceding the election;

It was MOVED by C. Guay, SECONDED by D. Eden, and unanimously RESOLVED; THAT in accordance with the Act Respecting School Elections, the Central Québec School Board adopt the proposal for the division of its territory into eleven (11) electoral divisions as presented; and

THAT as provided for in the Act Respecting School Elections, a copy of this resolution and the description of the electoral divisions be submitted to the *Commission de la représentation électorale* at the *Directeur général des élections du Québec*.

# d) Deposit of 2022–2023 Financial Statements

A. Landry, Director of Financial Services, made a detailed presentation on the CQSB's Financial Statements.

WHEREAS the audited financial statements for the 2022–2023 school year had been received by the Director General and presented to the Audit Committee on November 29, 2023;

WHEREAS the audited financial statements were submitted to the Council of Commissioners as required by the Education Act;

It was MOVED by J. Kilganan, SECONDED by J. Robert and unanimously RESOLVED; THAT the audited financial statements for the 2022–2023 school year be received.

e) Entente relative à la collaboration entre la commission scolaire et les corps de police à des fins de prévention et d'enquêtes ainsi qu'aux interventions de leurs membres en cas d'urgence ou de signalement d'un acte d'intimidation ou de violence

ATTENDU QUE la Commission scolaire a pour mission, en vertu de l'article 207.1 de la Loi sur l'instruction publique (RLRQ, chapitre I-13.3), d'organiser, au bénéfice des personnes relevant de sa compétence, les services éducatifs prévus par cette loi et par les régimes pédagogiques établis par le gouvernement;

e) Entente relative à la collaboration entre la commission scolaire et les corps de police à des fins de prévention et d'enquêtes ainsi qu'aux interventions de leurs membres en cas d'urgence ou de signalement d'un acte d'intimidation ou de violence (continued)

ATTENDU QUE la Commission scolaire a également pour mission, en vertu de l'article 207.1 de cette loi, de promouvoir et valoriser l'éducation publique sur son territoire, de veiller à la qualité des services éducatifs et à la réussite des élèves en vue de l'atteinte d'un plus haut niveau de scolarisation et de qualification de la population et de contribuer, dans la mesure prévue par la loi, au développement social, culturel et économique de sa région;

ATTENDU QUE la Commission scolaire veille, en vertu de l'article 210.1 de cette loi, à ce que chacune de ses écoles offre un milieu d'apprentissage sain et sécuritaire de manière à ce que tout élève qui la fréquente puisse y développer son plein potentiel, à l'abri de toute forme d'intimidation ou de violence et qu'à cette fin, elle soutient les directeurs de ses écoles au regard de la lutte contre l'intimidation et la violence;

ATTENDU QUE le Corps de police ainsi que chacun de ses membres ont pour mission, selon leur compétence respective énoncée notamment aux articles 48, 50 et 69 de la Loi sur la police (RLRQ, chapitre P-13.1), de maintenir la paix, l'ordre et la sécurité publique, de prévenir et de réprimer le crime et les infractions aux lois ou aux règlements pris par les autorités municipales sur le territoire de la municipalité à laquelle il est rattaché, dans le territoire pour lequel il est établi ainsi que sur tout autre territoire sur lequel il assure des services policiers et d'en rechercher les auteurs;

ATTENDU QUE l'article 214.1 de la Loi sur l'instruction publique prévoit qu'une commission scolaire et l'autorité de qui relève chacun des Corps de police desservant son territoire doivent conclure une entente concernant les modalités d'intervention des membres du Corps de police en cas d'urgence ainsi que lorsqu'un acte d'intimidation ou de violence leur est signalé et visant à mettre en place un mode de collaboration aux fins de prévention et d'enquêtes;

ATTENDU QUE le Règlement sur les ententes des commissions scolaires relatives à la collaboration à des fins de prévention et d'enquêtes avec les corps de police ainsi qu'aux interventions de leurs membres en cas d'urgence ou de signalement d'un acte d'intimidation ou de violence (RLRQ, chapitre I-13.3, r. 6.1, ci-après le « Règlement ») établit les éléments essentiels et les modalités particulières que doivent respecter de telles ententes ;

ATTENDU QUE cette entente tient compte des mandats, des directives et des procédures d'intervention propres à chacune des parties;

EN CONSÉQUENCE, il est PROPOSÉ par I. O'Gallagher, APPUYÉ par F. Pedneault et RÉSOLU à l'unanimité; QUE la Commission scolaire Central Québec, représentée par le Directeur général, M. Stephen Pigeon, soit autorisée à signer l'Entente relative à la collaboration entre la commission scolaire et les corps de police à des fins de prévention et d'enquêtes ainsi qu'aux interventions de leurs membres en cas d'urgence ou de signalement d'un acte d'intimidation ou de violence.

### f) Hiring of a General Contractor: Board Office Renovation Work

WHEREAS considering that the needs of certain departments have increased, and that the need for workspace is also on the rise;

WHEREAS considering that an extension of the premises is not feasible;

WHEREAS considering that the only way to enable efficient organization of work is to reorganize interior spaces to create the necessary space for workers;

WHEREAS plans and specifications were prepared and a public call for tenders for general contractors was published on SEAO on October 19, 2023, and the envelopes were opened on November 16, 2023;

WHEREAS the architect has recommended that the lowest tender be accepted as it met the requirements and specifications of the project;

It was MOVED by D. Cornforth, SECONDED by A. Gosselin and unanimously RESOLVED; THAT the Central Québec School Board's Council of Commissioners accept the lowest tender that met the specifications for the renovation works at the Board Office (2046, Chemin Saint-Louis, Québec, QC G1T 1P4) as submitted by Construction Bruno Blanchette/9048-6473 Québec Inc. (743, Rue des Chaînons, Québec, QC G1C 7V4), in the amount of \$261,163.00 (taxes not included); and

THAT the Director General be authorized to sign the contract on behalf of the School Board.

#### g) Motion to Become an Intervenor in the Constitutional Challenge to Bill 96

WHEREAS Bill 96, An Act respecting French, the official and common language of Québec, was assented to on June 1, 2022;

WHEREAS the same day the English Montreal School Board brought an application to challenge the constitutionality of numerous provisions of Bill 96 and the Charter of the French Language;

WHEREAS the English Montreal School Board's constitutional challenge to Bill 96 has been joined with the constitutional challenges of other parties and is progressing through the court system though, like all constitutional challenges, it is expected to be a lengthy process;

WHEREAS amendments to the Charter of the French Language that came into force on June 1, 2023, would require that English language school boards communicate with key institutions of the English-speaking community, such as the Quebec English School Boards Association, in French exclusively;

### g) Motion to Become an Intervenor in the Constitutional Challenge to Bill 96 (continued)

WHEREAS on September 29, 2023, the *Office québécois de la langue française* provided the English Montreal School Board with an interpretation of provisions of Bill 96 and the Charter of the French Language, which would effectively require that most internal written communications at the English Montreal School Board be conducted in French;

WHEREAS such an interpretation would also require that most written communications between commissioners of English-language school boards be conducted in French:

WHEREAS such an interpretation would also require that most written communications between English-language school boards be conducted in French;

WHEREAS the Québec Court of Appeal in its decision on the stay of Bill 40 recently reaffirmed that section 23 of the Canadian Charter prevents the province from interfering "with the linguistic and cultural concerns of the minority";

WHEREAS implementing provisions of Bill 96 and the Charter of the French Language, as interpreted by the *Office québécois de la langue française*, would fundamentally alter the linguistic culture;

WHEREAS implementing provisions of Bill 96 and the Charter of the French Language, as interpreted by the *Office québécois de la langue française*, would detract from the needs and priorities of the nine English language school boards, their students, parents and the broader community it serves;

WHEREAS all of these effects would lead to irreparable harm for the Englishlanguage community;

WHEREAS the Quebec English School Boards Association and all nine English school boards obtained a stay of Bill 40 in 2020, which was confirmed by the Québec Court of Appeal, based on the irreparable harm that implementing Bill 40 would cause to the English-speaking community, while waiting for a decision on the merits of the challenge;

It was MOVED by F. Pedneault, SECONDED by C. Lavallee and unanimously RESOLVED; THAT the Central Québec School Board become an intervenor in the constitutional challenge put forward by the English Montreal School Board; and

THAT the Central Québec School Board Council of Commissioners mandate the legal firm, Power Law, to institute on its behalf the appropriate legal proceeding.
