WHEREAS the architect has recommended that the lowest tender be accepted as it met the requirements and specifications of the project;

WHEREAS the Central Québec School Board has received confirmation from the Ministry that the lowest tender is accepted;

Toulouse and unanimously RESOLVED; THAT the Central Québec School Board's Council of Commissioners accept the lowest tender that met the specifications for the construction project of a new elementary school on the South Shore of Québec (1575 chemin du Sault, Lévis, QC G6W 2M2) as submitted by Construction Marc Drolet Inc. (5475, rue Rideau, Québec, QC G2E 5V9), in the amount of \$20,691,700.00 (taxes not included); and

THAT the Director General be authorized to sign the contract on behalf of the School Board.
