1. APPROVAL OF THE AGENDA

2. JUNE MINUTES—APPROVAL

21-GB-01 A motion to approve the amended June Minutes (changing Mr. for Ms. and vice versa, changing Mr. Johnston for Mr. Masson) was proposed by Mr. Robinson, seconded by Ms. Turcotte, and unanimously approved by all Governing Board members.

5. <u>NEW BUSINESS</u>

a) Extracurricular services - Decision

Each year, we have extracurricular services in our school. This year we have:

- **21-GB-05** A motion to approve these extracurricular services was proposed by Mr. Robinson, seconded by Ms. Delisle and unanimously accepted by all Governing Board members.

c) Daycare hours—Modification

Ms. Fréchette mentioned to the Governing Board members that we have fewer students attending Daycare after school. Students are leaving before 5:30 pm. Therefore, we suggest

that Daycare close at 5:30 pm. We reserve the right to make adjustments during the school year.

21-GB-07 A motion to approve the change of Daycare closing at 5:30 pm was proposed by Ms. Girard, seconded by Mr. Robinson, and unanimously accepted by all Governing Board members.

d) Ped Day activities 2021-2022

Ms. Fréchette presented to the Governing Board members, the Ped day activity calendar for this school year.

21-GB-08 A motion to approve the Ped day activity calendar for 2021-2022 was proposed by Ms. Garneau, seconded by Ms. McKenzie, and unanimously accepted by all Governing Board members.

e) Daycare regulations

Ms. Fréchette presented to the Governing Board members the Daycare regulations document with modifications due to the smaller number of students attending daycare:

- Closing daycare after school at 5:30
- Having a minimum of 20 students attending a ped day
- Noon hour fees: \$360.00 per year per student
- **21-GB-09** A motion to approve Daycare regulations was proposed by Ms. McKenzie, seconded by Ms. Garneau, and unanimously accepted by all Governing Board members.

f) Swimming lessons—Modifications

Ms. Fréchette brought the possibility of having 3 extra periods of swimming. This way, our students would strengthen their learning. We would have to charge \$10 extra, which would raise the total amount to \$140.

21-GB-10 A motion to approve an amount of \$140.00 for the swimming lessons was proposed by Ms. Garneau, seconded by Ms. Girard and unanimously accepted by all Governing Board members.

g) ABAM 2021-2022

Ms. Simard presented to the Governing Board members that Cycle 3 requested to have an ABAM program this year. Ms. Girard explained more in detail the different activities that will be held during this program. The total amount for ABAM program is \$100.00 per student.

21-GB-11 A motion to approve an amount of \$100.00 per student for ABAM program was proposed by Mr. Robinson, seconded by Ms. McKenzie and unanimously accepted by all Governing Board members.

h) Outings

Ms. Simard mentioned to the Governing Board members that this year, each Cycle has a maximum amount for their planned activities.

- **21-GB-12** A motion to approve Cycle One amount of \$72 per student for activities was proposed by Ms. Laviolette, seconded by Ms. Garneau and unanimously accepted by all Governing Board members.
- **21-GB-13** A motion to approve Cycle Two amount of \$56 per student for activities was proposed by Ms. Mayville, seconded by Ms. Delisle and unanimously accepted by all Governing Board members.
- **21-GB-14** A motion to approve Cycle Three amount of \$40 per student for activities was proposed by Ms. Mayville, seconded by Ms. Garneau and unanimously accepted by all Governing Board members.

i) Pre-K regulations

Ms. Fréchette informed the Governing Board members that Pre-K could be refreshed. The Governing Board members are inclined to revisit the Pre-K regulations this year.

N.B. For the next topic, Ms. Laviolette stepped out of the meeting because the next topic concerned her husband's request.

j) Mr. Beaulieu's request

Ms. Simard mentioned to the Governing Board members Mr. Beaulieu's request. Ms. Simard asked Ms. Laviolette to step out during this topic.

21-GB-15 A motion to deny Mr. Beaulieu's request was unanimously agreed by all Governing Board members.

k) Office Québécois de la Langue Française

Ms. Simard informed the Governing Board members that our school complied with all the complaints registered by L'Office de la Langue Française.

i) Annual Report

Mr. Robinson presented the Annual Report for 2020-2021 to the Governing Board members.

21-GB-16 A motion to approve the Annual Report 2020-2021 was proposed by Ms. Fréchette, seconded by Ms. Girard, and unanimously approved by all Governing Board members.

m) Programme de soutien à la mobilisation

Ms. Simard informed the Governing Board members about the Programme de soutien à la mobilisation.

n) Deferred revenues

Ms. Simard informed the Governing Board members that an amount of \$767 has been moved to this year's budget.

21-GB-17 A motion to approve the transfer of these deferred revenues was proposed by Ms. McKenzie, seconded by Mr. Ayre, and unanimously approved by all Governing Board members.

o) Dress Code

Ms. Simard presented to the Governing Board members, the new dress code.

21-GB-18 A motion to approve the Dress Code was proposed by Ms. McKenzie, seconded by Mr. Ayre, and unanimously approved by all Governing Board members.
